

Aspire AMZN2201 Promotion Terms and Conditions

1. These Terms and Conditions for Aspire AMZN2201 Promotion (the “**Promotion**”) are binding on all persons participating in the Promotion organised by Aspire FT Pte. Ltd. (referred to as “**Aspire**”).
2. The Promotion is valid from 13 January 2022 to 20 January 2022, with both dates inclusive (“**Promotion Period**”). Aspire reserves the right to alter, extend, cancel, terminate or suspend the Promotion or any part thereof or any part of the applicable terms and conditions from time to time, without prior notice.

Eligibility

3. To participate in this Promotion and be eligible for the Promotion Reward(s) (as defined below):
 - a. The Applicant must submit a new Aspire business account application between 13 January 2022 to 20 January 2022, both dates inclusive (“**Promotion Period**”);
 - b. The Applicant must sign up with the promo code “**AMZN2201**” at point of registration;

Where all the criteria in 3(a) to 3(b) are met, applicants are referred to as “**Eligible Applicants**”.

Interpretation

4. For the purpose of this promotion:
 - a. “**Qualified Card Spend**” refers to expenses transacted on the Aspire card(s) that are made at **Qualifying Merchants** and which are incurred to purchase online marketing and software as a service* services. You may refer to the full list of Qualifying Merchants (which Aspire retains the sole and absolute discretion to change from time to time) below:

* Where any doubt exists as to whether a transaction qualifies as "online marketing" and "software as a service" for the purposes of the Promotion, Aspire shall be the sole and final arbiter of any decision as to the qualification of the transaction and will entertain no other disputes, complaints or disagreements thereto.

b. Qualifying Spend exclusions:

- i. Refund(s) into the Aspire business account;
- ii. Pre-authorisation transactions on the Aspire Card;
- iii. Payment of funds to prepaid accounts and merchants who are categorized as "payment service providers" and/or "online payment gateway". For example, Grab top-up, FAVEPAY topup, Carousell, MoneySend, Skrill.com, Matchmove.com, SmoovPay, CardUp, iPaymy, Ez-Link, NETS, YouTrip, Revolut, Wise.
- iv. Any other transactions determined by Aspire from time to time.

Promotion Reward

5. Subject to the fulfilment of Clause 3, the Eligible Applicant will be entitled to receive a cash reward of S\$250 when they complete a minimum qualified card spend of S\$5.00, at any of the listed Qualifying Merchants by 31 January 2022.
6. The Eligible Applicant will further be entitled to receive an additional S\$250 in cash reward when they:
 - a. Issue a second Aspire card; and

- b. Complete a minimum qualified card spend of S\$5.00 at a different Qualifying Merchant, using the second Aspire card, by 31 January 2022.
7. Once the Eligible Applicant has met any of the Promotion Reward criteria as set out in Clause 5 and 6, the relevant Promotion Reward(s) will be credited directly to the Eligible Applicants registered Aspire business account by 15 February 2022.

General Terms and Conditions

8. The Eligible Applicants Aspire business account and Aspire Card must be at good standing or not blocked for use and conducted in a proper and satisfactory manner as determined by Aspire in its sole discretion at the time of crediting the Promotion Reward. In the event that the relevant account is delinquent, voluntarily closed or terminated or blocked for use for any reason whatsoever before the Promotion Reward is credited into the said account, Aspire reserves the right not to credit the Promotion Reward.
9. Aspire reserves the right at any time without giving any reason or notice to you to deduct, withdraw or cancel any Promotion Reward awarded to you without liability. You will not be entitled to any payment or compensation whatsoever in respect of such deduction, withdrawal or cancellation.
10. Aspire's decision on all matters relating to the Promotion Reward shall be final. No correspondence or claims will be entertained.
11. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotional material relating to the Aspire Business Account, these Terms and Conditions shall prevail.

13. All Aspire Card cardholders consent under the Personal Data Protection Act (Cap 26, 2012) to the collection, use and disclosure of their personal data by / to Aspire and such other third party as Aspire may reasonably consider necessary for the purpose of the Promotion.
