

Aspire Great Singapore Sale 2021 Promotion Terms and Conditions

1. The Aspire Great Singapore Sale 2021 Promotion (the “Promotion”) is offered by Aspire FT Pte. Ltd. (“Aspire”) between **14 June to 31 July 2021** (the “Promotion Period”), both dates inclusive. By participating in this Promotion, you agree to be bound by these terms and conditions.

Eligibility

2. To qualify for the Promotion and receive the cashback available as set out in Clause 4 - 7 below, you must fulfill all the following criteria:
 - a. Not have an existing Aspire business account at the time of the sign up;
 - b. Signed up for a new Aspire business account with the promo code ‘**GSS2021**’ during the Promotion Period;
 - c. Must have your Aspire business account and Aspire card in good standing with Aspire during the Cashback Promotion Period;
 - d. Credited your sales revenue from one of the listed Qualified E-commerce Platforms to your Aspire business account during the Cashback Promotion Period;
 - e. For every calendar month during the Cashback Promotion Period, the total sum of incoming sales revenue from any of the Qualified E-commerce Platforms, must be greater than the total sum of Qualified Spend of the Aspire account.
3. The incoming sales revenue credited to the Aspire account must be from one of the listed e-commerce platforms (“Qualified E-commerce Platforms”) shown below:
 - a. Carousell;
 - b. GrabPay;
 - c. Google AdSense;
 - d. HitPay;
 - e. Hoolah;
 - f. Lazada;
 - g. PayPal;

- h. Shopee;
- i. Shopify;
- j. Stripe;
- k. Wix.

Or any such other e-commerce platforms as may be determined by Aspire in its absolute discretion.

Cashback Promotion

4. Subject to these terms, if you satisfy all the eligibility criteria set out in Clause 2 above, you are entitled to receive **5% cashback** (“Cashback Promotion”) on online marketing and Software as a Service* transactions (“Qualified Spend”) through your Aspire card, including the remaining cards that have been issued under your Aspire account.
5. This Cashback Promotion is valid for a period of **90 calendar days** from the date of a successful Aspire business account verification (“Cashback Promotion Period”). Thereafter, your account will be reinstated to the standard 1% cashback scheme on Qualified Spend.
6. You are entitled to receive cashback on the quantum of 5% of the Qualified Spend for transactions made on the Aspire card with a maximum cashback of up to S\$2,500 (“Payout Cap”) for the relevant month during the Cashback Promotion Period.
7. For every calendar month during the Cashback Promotion Period, should the total sum of incoming sales revenue from any of the Qualified E-commerce Platforms be less than the total sum of Qualified Spend of the Aspire account, the total Qualified Spend for that particular month will receive cashback on the quantum of 1% for transactions made on the Aspire card with no maximum cashback cap.
8. Aspire reserves the right to unilaterally amend the Payout Cap at any time in its sole and absolute discretion and without giving any reasons to you. Aspire will inform customers in good time of any amendments to the Payout Cap.
9. Qualified Spend means expenses transacted on the Aspire Card that are made at qualifying merchants and which are incurred to purchase online marketing and software as a service services in order to qualify for the Cashback Promotion. You may refer to the full list of Qualifying Merchants [here](#) (which Aspire retains the sole and absolute discretion to change from time to time).

10. Cashback earned by you will be credited to your Aspire Business Payment Account following the month that the Qualified Spend is made.

* Where any doubt exists as to whether a transaction qualifies as "online marketing" and "software as a service" for the purposes of the Cashback Promotion, Aspire shall be the sole and final arbiter of any decision as to the qualification of the transaction and will entertain no other disputes, complaints or disagreements thereto.

General Terms and Conditions

11. Aspire reserves the right at any time without giving any reason or notice to you to deduct, withdraw or cancel any Cashback awarded to you without liability. You will not be entitled to any payment or compensation whatsoever in respect of such deduction, withdrawal or cancellation.

12. Aspire's decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.

13. In the event of any inconsistency between these Terms and Conditions and any brochure, marketing or promotional material relating to the Promotion, these Terms and Conditions shall prevail.

14. Aspire may vary these Terms and Conditions or suspend or terminate the Promotion without any notice or liability to any party.

15. All Aspire Card cardholders consent under the Personal Data Protection Act (Cap 26, 2012) to the collection, use and disclosure of their personal data by / to Aspire and such other third party as Aspire may reasonably consider necessary for the purpose of the Promotion.
